and,

Whereas the said term of Prof. Bandopadhyay expired on 16-02-2015;

and,

Whereas the term of Professor Bandopadhyay was further extended for a period of 12 (twelve) months as the first Vice-Chancellor of Bankura University w.e.f. 17.02.2015 vide this Department's Notification No. 109-Edn(U)/BKU-01/14 dated 06-02-2015;

and,

Whereas the said term of Professor Bandopadhyay as the first Vice-Chancellor of Bankura University expired on 16.02.2016;

and,

Whereas the term of Professor Bandopadhyay was further extended for a period of one year as the first Vice-Chancellor of Bankura University w.e.f. 17.02.2016 vide this Department's Notification No. 36-Edn(U)/BKU-01/14 dated 18-01-2016;

and,

Whereas the said term of Professor Bandopadhyay as the first Vice-Chancellor of Bankura University is due to expire on 16.02.2017;

Now, in exercise of the powers conferred under clause (a) of sub-Section (4) of Section 58, read with sub-section (11) of Section 59 of the Bankura University Act, 2013 (West Bengal Act XIX of 2013), the Chancellor is pleased to extend the term of Prof. Deb Narayan Bandyopadhyay as the first Vice-Chancellor of Bankura University for a further period of 6 (six) months w.e.f. 17-02-2017 or till a regular Vice-Chancellor is appointed through the search process or Prof. Bandyopadhyay attains the age of 65 (sixty-five) years [ D.O.B. 01.01.1954] or until further orders, whichever is the earliest.
