## **NOTIFICATION**

Sub: Guidelines for admission in MCA Programmes through decentralized counselling process for the academic year 2015-16

Whereas, the necessary guidelines for admission to MCA Programmes in the academic session of 2015-16 through the State Level Common Entrance Examination for the said program (i.e. JECA-2015) has already been notified and published by the West Bengal Joint Entrance Examinations Board vide Notification No. WBE/CN-169, Dated, the 7<sup>th</sup>. August, 2015

#### And

Whereas, in the said guidelines the West Bengal Joint Entrance Examinations Board has declared the necessary venue, period of counselling, application procedure, counselling fee, eligibility criteria, reservation policy as well as other relevant information towards admission to MCA program in the academic session of 2015-16;

#### And

Whereas in the said guidelines it has been mentioned that candidates will take admission to the allotted University and Institutes within five days from the date of allotment by the West Bengal Joint Entrance Examinations Board through the centralised counselling process;

### And

Whereas it has been observed that the seats are remaining vacant after the completion of such allotment and admission process in different participating Universities and Institutes of the State offering MCA programme.,

Now, therefore it is clarified that on completion of the centralised counselling and admission process, the participating Universities and Institutes of the State may pursue the

admission procedure in the MCA Programmes in the Universities and Institutes as notified here under :

- a. For different participating Universities and Institutes, the eligibility criteria for admission through decentralised counselling process for MCA Programmes follows the same as notified in the guidelines issued by the West Bengal Joint Entrance Examinations Board vide Notification No. WBE/CN-169, Dated, the 7<sup>th</sup>. August, 2015.
- b. The participating Universities and Institutes willing to admit students through such decentralised counselling process shall have to follow a complete transparent admission procedure inviting application from JECA-2015 qualified candidates by posting necessary Notice, declaring vacancy position in respect of the said MCA Programmes, in their respective Notice Board and/or the Institutional website.
- c. The admission for such MCA Programmes will have to be in strict observance to the merit list of the JECA-2015 conducted by the West Bengal Joint Entrance Examinations Board
- d. The cut-off date for completion of the decentralised counselling and admission at the respective participating University and Institution will have to be in accordance to the academic calendar of the concerned Affiliating University for the academic year 2015-16.
