<u>Eligibility:</u> Officer of the Central Governments or State Government or Union Territories or Public Sector Undertakings or Universities or Recognised Research Institutions or Autonomous or Semi Government or Statutory Organisations:

(a) (i) Holding analogous posts on regular basis in the parent cadre or department; or

(ii) with two years service in the grade rendered after appointment thereto on regular basis in the pay band -2, Rs. 9300-34800 with grade pay Rs. 4600/- or equivalent; or

(iii) with six years' service in the grade rendered after appointment thereto on regular basis in the pay band -2, Rs. 9300-34800 with grade pay Rs. 4200/- or equivalent; and

(b) Possessing the following educational qualifications and experience:-

Essential: (i) Masters' Degree in one of the two languages for which recruitment is made, with English as a subject at degree level from a recognized University;

(ii) Should have offered the language other than the one in which Master's degree has been obtained in terms of (i) above (other than Hindi) as a subject at secondary education level or should hold a diploma in that language.

(iii) One year experience in teaching one of the two languages (other than Hindi) for which recruitment is made in a recognized school or college.

Desirable: Degree in Education from a recognized University.

Age Limit: The age limit for appointment by deputation (ISTC)/absorption basis shall not exceed 56 years as on the closing date of receipt of application.

**<u>Period</u>**: Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same shall not ordinarily exceed three years.

<u>Duties and responsibilities of the Post include:</u> To undertake full time teaching of the subject to the probationers of All India Services and Central Service Group 'A' and conduct syndicate studies and guide academic work. Preparation of reading material, setting of examination paper etc.

The candidate selected for deputation will be entitled to training allowance @ 30% in lieu of deputation allowance of his/her basic pay in the parent department, if deputationist opts for the pay scale of his/her parent department.

Note: Officers belonging to Central Government or State Government or Union Territories shall only be eligible for being considered for appointment on absorption.
