

Sir,


As you are kindly aware that renewal of "Aikyashree" scholarship is one of the services which is being provided from the Duare Sarkar Camp (16th August to 15th September).

In the year 2020-2021, we were able to provide more than 39 lakh scholarships to the students under this Scheme. This year we are expecting that at least 20-25 lakhs students would apply for scholarship under the Scheme through the Duare Sarkar Camps. Also, the receiving of fresh applications has started, though it is not part of the Duare Sarkar.

For sanctioning the scholarship in a time bound manner, the 1st level of verification of the applications at the Institute Level is of utmost importance.

I would request you to kindly issue necessary instructions to head of all the schools/ colleges/ universities under your department to complete the verification of the applications for scholarship of the students studying in their institutions within 2-3 days of the filing of applications in order to achieve the target set for Duare Sarkar campaign as well as for the year.


