**NOTIFICATION**

In exercise of the powers conferred under section 9 (1)(c) of Gour Banga University Act, 2007(West Bengal Act XXVI of 2007), as amended by the West Bengal University Laws (Amendment) Act, 2012 and West Bengal University Laws (Amendment) Act, 2014, the Governor is pleased to constitute the 'Search Committee' for recommending a panel of names for the post of Vice-Chancellor of Gour Banga University, consisting of the following members:

- i. Prof. Sabyasachi Basuray Chowdhury, Vice-Chancellor of Rabindra Bharati University - Nominee of the Chancellor, who shall be the Chairperson of the Committee;
- ii. Prof. Subires Bhattacharyya, Vice-Chancellor of North Bengal University - Nominee of the State Government.
- iii. Prof. Nimai Chandra Saha, Vice-Chancellor of Burdwan University - Nominee of the Court.

The Chairman of the 'Search Committee' will furnish the following along with the panel of recommendation of the 'Search Committee':

- a) the numbers of applicant for the post of the Vice-Chancellor
- b) the numbers of applicants eligible for consideration
- c) list of all eligible candidates mentioning their date of birth and summary of qualifications
- d) eligibility of the persons to be recommended in the panel as per provision the Act, Statute and Rules etc., as applicable.

2) Secretarial assistance to the Committee will be provided by the Registrar, Gour Banga University and the related expenditure for this purpose (like travelling allowances, office expenses, etc.) too shall be borne by the University.

3) The Registrar, Gour Banga University, under intimation to this Department, shall contact the Search Committee at the earliest and provide assistance in discharge of its functions.


