NOTIFICATION

In exercise of the powers conferred by sub section (5) of section 65 of the West Bengal University of Teachers, Training, Education Planning and Administration Act, 2014, (West Bengal Act XXI of 2014), the Governor is hereby pleased to appoint the 1st day of October, 2018 as the "Appointed Day" for the West Bengal University of Teachers, Training, Education Planning and Administration. Accordingly, the provisions of section 66 of the West Bengal University of Teachers, Training, Education Planning and Administration Act, 2014, (West Bengal Act XXI of 2014), shall stand repealed with effect from 01.10.2018.

In this connection, the Governor is further pleased to direct that the Court (composition is mentioned in Schedule-A) and the Executive Council (composition is mentioned in Schedule-B) of the West Bengal University of Teachers, Training, Education Planning and Administration shall become functional on and from the 1st day of October, 2018. The First Statutes of the University shall also come into effect from the 1st day of October, 2018.

The West Bengal University of Teachers, Training, Education Planning and Administration Council as constituted under section 66 of the Act, shall stand dissolved with effect from the 1st day of October, 2018.

The Governor is also pleased to direct that all other authorities of the University, as constituted under the First Statutes of the University, will come into effect from the 1st day of October, 2018.
