**NOTIFICATION**

After completion of JEHOM-2018 (Joint Entrance for Hotel Management & Catering Technology – 2018) Counseling, the West Bengal Joint Entrance Examinations Board (WBJEEB) has informed that most of the offered seats under the Hotel Management & Catering Technology Programme for the academic session 2018-19 are lying vacant.

And whereas the NSHM Knowledge Campus, Durgapur has also reported that the number of candidates taking admission in the 4-years Bachelor in Hotel Management & Catering Technology Programme has not been enough this year fill up the total sanctioned seats and accordingly the Institute requested the State Govt. to allow de-centralised counseling (Institution Level) as has been done in the previous years to fill up the vacant seats.

And whereas it is always the attempt of this Department to fill up the said vacant seats as far as possible by eligible candidates through de-centralised counseling at the Institution Level.

Therefore, it has been decided that the said seats pertaining to 1<sup>st</sup>-year Degree Level of BHMCT Programme conducted by the NSHM Knowledge Campus, Durgapur will be opened to fill up the same through de-centralised counseling (Institution Level) by the aspiring candidates having requisite eligibility criteria of AICTE shall be filled up strictly by a list prepared on the basis of merit.

For this purpose, the said Institute will post notice on their notice board and website inviting applications from intending candidates for the de-centralised counseling programme and thereafter admit students strictly on the basis of merit through De-centralised Counseling to be conducted in one/two days in presence of an authorised representative of Directorate of Technical Education, Govt. of West Bengal.
