**NOTIFICATION**

On the basis of recommendation of the Public Service Commission, West Bengal, vide their letter No. 609-PSC(Selection)/1S-65/2015 (pt. II), dated 27/07/2017, the Governor was pleased to appoint **provisionally Shri Prasenjit Dey**, son of Provat Kumar Dey, Kanjial Para, Rajarhat, Dist.-North-24-Parganas, Kolkata - 700135 to the post of Assistant Professor in **Computer Science & Engineering** in the W.B.G.S. for two years in the Pay Band of Rs. 15,600-39,100/- plus AGP of Rs 6,000/- p.m. with usual allowances with effect from the date of his joining, pending verification of his antecedents and medical examination report and posted him at the Cooch Behar Government Engineering College, Cooch Behar on the condition that the appointment would be liable to be cancelled in the event of any adverse Police Verification Report or Medical Examination Report, vide this Department's Notification No. 34-Edn(T)/4A-09/2017(7) dated: 17.01.2018. On receipt of satisfactory police verification report and medical examination report, the Governor has now been further pleased to appoint **Shri Prasenjit Dey, temporarily on regular basis** as Assistant Professor of **Computer Science & Engineering** in the Govt. Engineering & Technological Colleges in the West Bengal General Service in the scale of Pay Band of Rs. 15600-39100/- with AGP of Rs. 6000/- plus usual allowances with effect from 28.06.2018.
