MEMORANDUM

In continuation of this Department's earlier Memo.No.:73-HED-21014(23)/4/2020-SE SEC-Dept. of HE dated 02.11.2020, the undersigned is directed to state that the benefits of the West Bengal Services (Revision of Pay and Allowances) Rules, 2019 may be applied mutatis-mutandis towards revision of scale of pay of the employees in the Govt. approved academic posts in the Netaji Institute for Asian Studies, Kolkata to the extent of the following points:-

- i. From the existing Pay Band and Academic Grade Pay, the Pay of each employee in the academic posts will be revised to the corresponding level in the Pay Matrix notionally with effect from 01.01.2016 with actual effect from 01.01.2020. [Annexure I, II and III are enclosed herewith]
 - ii. The employees in the academic posts shall come under the revised pay structure with effect from 01.01.2016 only.
 - iii. The Pay of the employees directly appointed to any post after 01.01.2016, shall be fixed at the minimum pay structure i.e. at the first cell of the Level attached to the post from the date of joining.
- 2. The initial pay of each employee in the appropriate Level of the revised pay structure shall be fixed as per provisions of rule 7(1) of the WBS (ROPA) Rules, 2019. Rule 7(4) ibid shall be applied, where necessary [Annexure III is enclosed herewith].
- 3. Increments in Pay Matrix shall be regulated as per provisions of rule 9 and rule 10 of the WBS (ROPA) Rules, 2019.
- 4. With effect from 01.01.20, the employees in the academic posts will get House Rent Allowance @12% of revised Basic Pay subject to a maximum of Rs.12000/- (Rupees twelve thousand) per month. The ceiling of House Rent Allowance to be drawn by husband and wife shall be restricted to Rs.12000/- (Rupees twelve thousand) per month. The existing terms and conditions for drawal of such allowance shall remain the same.

- 5. With effect from 01.01.2020 the employees in the academic posts will be entitled to draw Medical Allowance @Rs.500/- (Rupees five hundred) per month provided that the concerned employee is not covered under ESI Scheme or any Medical Benefit Scheme sponsored by the Government.
- 6. There will be no arrear for the period from 01.01.2016 to 31.12.2019.
